## Alternatives to Living in Violent Environments Fiscal Year April 1, 2014 through March 31, 2015 Annual Report

### Program Accomplishments

Since 1983, ALIVE has provided services to restore safety peace to St. Louis area domestic abuse victims and their children. In Fiscal Year 2014/15 ALIVE served 1,827 adults and children through its two offices in St. Louis County and Franklin County, Missouri. By offering an array of programs and partnering with other community resources, ALIVE provides customized services based on specific client needs.

**ALIVE's 24-Hour Crisis Line** provides clients with their first access to ALIVE services. 9,099 crisis calls were answered in 2014/15.

**Nights of Safety** temporary emergency shelter is a critical safety net for families impacted by domestic abuse. Utilizing area motels in safe locations when shelters are unavailable, 5,436 Nights of Safety were provided to 302 adults and 406 children in 2014/15.

**Transportation** to safe shelter and key appointments is challenging for clients with limited resources. Using cabs, buses, and gas cards, ALIVE provided transportation to 841 adults and 689 children in 2014/15.

**Adult Counseling and Support Groups** address past trauma and support well-being. In 2014/15, ALIVE provided 3,905 hours of counseling to 385 clients, and 46 individuals attended 74 support groups.

**Court Advocacy** specialists assist clients in navigating the legal system, including orders of protection and divorce/custody actions. In 2014/15, ALIVE assisted 385 clients with 600 court actions.

**ALIVE's Children's Treatment Program** offers the only area non-residential counseling addressing the needs of children who are secondary victims of domestic violence, ALIVE provided 1,106 hours of counseling to 268 children and their parents in 2014/15.

**Community Education** is vital to recognizing and preventing domestic violence. ALIVE made 69 presentations to 1,860 individuals in 2014/15.
