Alternatives to Living in Violent Environments Fiscal Year April 1, 2016 through March 31, 2017 Annual Report

Program Accomplishments

Since 1983, ALIVE has provided services to restore safety peace to St. Louis area domestic abuse victims and their children. In Fiscal Year 2016/17 ALIVE served 3,060 adults and children through its two offices in St. Louis County and Franklin County, Missouri. By offering an array of programs and partnering with other community resources, ALIVE provides customized services based on specific client needs.

ALIVE's 24-Hour Crisis Line provides clients with their first access to ALIVE services. 6,082 crisis calls were answered during 2016/17.

Nights of Safety temporary emergency shelter is a critical safety net for families impacted by domestic abuse. Utilizing area motels in safe locations when shelters are unavailable, 7,694 Nights of Safety were provided to 546 adults and their 907 children during 2016/17.

Transportation to safe shelter and other critical resources is challenging for clients with limited finances. Using cabs, buses, and gas cards, ALIVE provided transportation to 497 adults and 638 children during 2016/17.

Adult Counseling and Support Groups address past trauma and support well-being. During 2016/17, ALIVE provided 4,054 hours of counseling to 391 clients, and facilitated 51 support groups for 36 individuals.

Court Advocacy specialists assist clients in navigating the legal system, including Orders of Protection and divorce/custody actions. During 2016/17, ALIVE assisted 487 clients with 864 court actions.

ALIVE's Children's Treatment Program offers the only area non-residential counseling addressing the needs of children witnessing domestic abuse. ALIVE provided 1,366 hours of counseling to 261 children and their parents during 2016/17.

Community Education is vital to recognizing and preventing domestic violence. ALIVE made 116 presentations to 5,963 individuals in 2016/17.

ALIVE's Mission

is to provide counseling, emergency sanctuary, and other critical services to adults and children impacted by domestic abuse, as well as to increase awareness in order to create a supportive community.
